US Senate Passes FAA Reauthorization Bill

Summary of Facts

On May 9, the Senate approved H.R.3935, which would reauthorize the FAA for another five years, with a decisive 88–4 vote. The measure allocates more than \$105 billion for the agency through fiscal 2028.

The approval came after extensive negotiations during which nonaviation-related amendments were excluded. The bill addresses crucial aviation issues, including workforce development, pilot training, flight disruptions, and the advancement of innovative technologies such as advanced air mobility and uncrewed aircraft systems.

In addition, the House approved and the Senate passed a one-week extension (H.R.8289) before recessing for the week, to ensure uninterrupted air operations until the legislation's final approval. This is Congress's fourth short-term FAA extension since September 2023 because of disagreements over the bill's language.

The House is expected to review the comprehensive FAA bill Tuesday, May 14.

VAI Position and Actions

VAI applauds congressional leaders for moving forward with a bipartisan FAA reauthorization bill. The bill provides significant improvements for general aviation and the vertical aviation industry specifically. This legislation supports several priorities that VAI has endorsed, including aviation safety, workforce development, and advanced air mobility. VAI looks forward to the House passing the bill before the current authorization expires on May 17.

Upon the bill's full passage, VAI will publish a summary of the bill highlighting the significant provisions impacting the vertical flight industry. VAI members should be on the lookout for this summary, which will be available on <u>our advocacy website</u>.

Hawaii Bill Proposing Inaccessible Operator Insurance Rates Dies in Conference

Summary of Facts

Hawaii State <u>Senate Bill 2747</u> (S.B.2747), which threatened to impose inaccessible insurance rates on air tour operators in Hawaii, died in legislative conference earlier this month.

The bill, which initially had passed both the Hawaii Senate and House, required air tour operators to maintain aircraft liability insurance coverage of \$20 million per person per incident (as amended). State Sen. Chris Lee (D-District 25) had introduced the bill in January with a liability coverage requirement of at least \$1 million per person per incident. The Senate Committee on Transportation and Culture and the Arts, however, removed the \$1 million threshold and advanced the bill to the House Committee on Consumer Protection & Commerce (CPC) to review the language and assign a more accurate rate, given the committee's expertise in addressing insurance limits.

The House CPC amended the bill in early April, increasing the liability insurance requirement for air tour operators to \$20 million per person per incident.

VAI Position and Actions

VAI took proactive steps to oppose S.B.2747, collaborating with industry peers including the Aircraft Owners and Pilots Association, the National Business Aviation Association, and the National Air Transportation Association. In addition, VAI engaged in productive dialogue with Hawaii state legislators to address the vertical aviation industry's concerns about the bill, emphasizing the potential financial burden and regulatory conflicts the bill posed. Primary industry concerns included the impracticality of obtaining the specified insurance coverage at a reasonable cost and the risk of violating FAA grant assurances, potentially jeopardizing Hawaii's federal funding for airport improvement programs.

VAI appreciates the constructive dialogue with Hawaii state legislators and their receptiveness to our members' input.
