Senate Committee Holds Nomination Hearing for FAA Administrator Candidate

Summary of Facts

Last week, the Senate Committee on Commerce, Science, and Transportation conducted a nomination hearing for Michael Whitaker, President Biden's nominee for the role of FAA administrator. Whitaker has garnered substantial support from both the commercial and general aviation industries as well as bipartisan backing. The upcoming Senate committee vote on Oct. 18 is expected to favor Whitaker, advancing his nomination. Upon a successful committee vote, Whitaker's nomination would then move to the full Senate for approval.

HAI Position and Actions

HAI emphasizes the importance of Whitaker's nomination progressing and is excited about the potential appointment of a permanent FAA administrator to lead the agency.

Utah Rotor Pathway Program Holds 2nd Annual Fly-In Event

Summary of Facts

The Utah Rotor Pathway Program (URPP) held its second annual fly-in on Oct. 5, 2023, at the Davis Catalyst Center in Kaysville, Utah. This event, which featured multiple helicopters and numerous industry displays, introduced students to the world of vertical flight and the many exciting job opportunities it offers. The event featured pilots and mechanics sharing their experience in and passion for the helicopter industry. The event allowed students to interact with those already in the industry, see helicopters up close, and learn how they can pursue careers in this field.

The URPP serves as a first-in-the-nation model for education and training programs preparing high school students for STEM (science, technology, engineering, and math) careers in rotarywing aviation. The program connects rotorcraft industry professionals with high schools, flight schools, and universities to offer benefits such as mentoring, internships, and job interviews upon students' completion of rotary-wing aviation programs.

California SB-800 Signed into Law

Summary of Facts

Last week, California enacted Senate Bill No. 800, a pivotal law addressing advanced air mobility (AAM) technology. The legislation mandates that the California Department of Transportation (Caltrans), in collaboration with the California Office of Planning and Research and the California Air Resources Board, form an advisory committee. This committee is tasked with evaluating various aspects of AAM adoption, including viable approaches for implementing electrification goals within the aviation sector. The legislation also requires the committee to report its findings no later than Jan. 1, 2025.

HAI Position and Actions

HAI had previously submitted written testimony and a coalition letter endorsing SB-800, and we are pleased to see its successful passage. We are encouraged to see California facilitating the secure and efficient integration of AAM into the state's vertical aviation market.

European Parliament Adopts ReFuelEU Rules to Decarbonize the Aviation Sector

Summary of Facts

The European Parliament has approved the ReFuelEU aviation rules, part of the Fit for 55 package of proposals adopted by the European Commission in July 2021. ReFuelEU seeks to boost sustainable aviation fuels (SAFs) in the European Union (EU) air transport market. The new law aligns air transport with EU climate targets for 2030 and 2050, addressing issues such as low supply and high SAF prices compared with fossil fuels.

Fit for 55 aims to reduce net greenhouse gas emissions, by 2030, by at least 55% compared with 1990 levels. The package encompasses the European Union's climate, energy, land-use, transportation, and taxation policies.

VTOL Advocate Oct1623

ReFuelEU mandates that aviation fuel suppliers include a minimum share of SAF in fuel provided at EU airports as follows: 2% in 2025, 6% in 2030, and 70% in 2050. From 2030 on, 1.2% must be synthetic fuels, rising to 35% by 2050. Aircraft operators must uplift at least 90% of yearly aviation fuel required at an EU airport to avoid additional emissions from excess weight.

The regulation, to be published soon, comes into force on the 20th day after publication in the *Official Journal of the European Union*, effective from Jan. 1, 2024. However, certain articles of the regulation will apply from Jan. 1, 2025, on.
